(i) Full Membership

All Government, Aided and Direct Subsidy Scheme secondary schools using English as the medium of instruction for all subjects in all classes of all levels with the possible exception of Chinese History, Chinese Language, Chinese Language and Culture, Chinese Literature, Putonghua, Liberal Studies / Citizenship and Social Development, Buddhist Studies, Ethics and Religious Studies, Religious Studies, Design and Technology, Technology and Living, Music, Visual Arts and Physical Education shall be eligible for Full Membership.

(ii) Associate Membership

All Government, Aided and Direct Subsidy Scheme secondary schools using English as the medium of instruction for all subjects in all classes of at least one level with the possible exception of those listed in (i) above shall be eligible for Associate Membership.
